Putting our policy into practice

- We will promote safeguarding by ensuring a copy of the safeguarding policy statement is prominently displayed on the notice boards: outside the Minister's office, and in the foyer.
 The statement and the policy guidelines are available on the church website
- Each worker with children, young people and / or adults at risk whether paid or voluntary, will be asked to read in full the safeguarding policy and procedures, and sign to confirm that they will follow them
- A full copy of the policy and procedures will be made available on request to any member of the church, the parents, family or carers of any child, young person or adult at risk, or any other person associated with the church
- The policy and procedures will be monitored and reviewed at least annually by the safeguarding team, and any necessary revisions adopted into the policy and implemented through our procedures
- The policy statement will be read annually at the church members' meeting in May together with a report on the outcome of the annual safeguarding review.
